## INVITATION FOR AHEC ALUMNI: “Interprofessional Village” and Healthcare Case Competition observation at the Kalahari Resort



Wisconsin AHEC invites you to join us for an interprofessional learning fair and to view the IP Healthcare Case Competition presentations at the Kalahari Resort on Friday, January 13, 2017.

### What's the Interprofessional Healthcare Case Competition?

Wisconsin AHEC has invited students from all Wisconsin colleges/universities to compete in a case competition event during the Fall 2016 semester, culminating in a special event held in the Wisconsin Dells (January 12-13, 2017).

- Health professions students from various degrees or disciplines will compete, on a team of 4-5 students, with at least three different degrees/professions represented.
- Teams work together from Oct. - Dec.
- Each team will conduct an analysis of interprofessional efforts during the care of a patient/client (case study provided to team).
- Top teams will travel to Wisconsin Dells January 12-13, 2017, to present their case to a panel of judges representing various disciplines in the community of Wisconsin's healthcare professionals.
- Cash prizes awarded to winning teams.

### Learning fair - “Interprofessional Village”

A resource fair with a station for each health profession at its own table, the “Interprofessional Village” is an opportunity for attendees to explore roles & responsibilities, values & ethics, and teamwork through the perspectives of different health care professionals. Students are issued an “IP Passport” to travel among stations within the IP village. At each station, individuals engage in a brief discussion/activity with the table host and receive a passport stamp. Completed IP passports can be turned in for a chance at prizes. Prize drawings will occur throughout the day.

### When and where is the IP Village?

The IP Village runs concurrently with the team presentations during the competition, in an adjoining ballroom. AHEC alumni may attend morning, afternoon, or both sessions of the IP Village. Lunch will be provided by Wisconsin AHEC.
